  - MARK PERSONAL FOULS BY QUARTERS USING: '1' 1<sup>st</sup>; '2' 2<sup>nd</sup>; 'X' 3<sup>rd</sup>; 'O' 4<sup>th</sup>; '+' OVERTIME
  - MARK TECHNICAL FOULS AS 'T'
  - MARK FOUL SHOT USING: 'O' FOR MISSED; 'X' FOR SCORED
